An Act to provide that certain enactments of the Parliament of New Zealand shall extend to the Cook Islands as part of the law of the Cook Islands

(4 October 1968)

BE IT ENACTED by the Legislative Assembly of the Cook Islands in Session assembled, and by the authority of the same, as follows:

1. Short Title - This Act may be cited as the New Zealand Laws Act 1968.
2. New Zealand Acts extended to the Cook Islands - The Acts of the Parliament of New Zealand specified in the First Schedule to this Act are hereby declared to extend to the Cook Islands as part of the law of the Cook Islands.
3. New Zealand regulations and orders extended to the Cook Islands - The regulations and orders specified in the Second Schedule to this Act are hereby declared to extend to the Cook Islands as part of the law of the Cook Islands.
4. Regulations revoked - The Adhesive Stamps Regulations 1940 as applicable to the Cook Islands are hereby revoked.
