REGULATIONS

1. Title. - These regulations are the International Trusts (Prescribed Fees) (Amendment) Regulations 2012 and shall be read together with and deemed part of the International Trusts (Forms and Fees) Regulations 1985 (hereinafter called "the principal regulations").

2. Commencement - These regulations are deemed to have come into force on the 10th day of December 2011.

3. Prescribed fees - The principal regulations are amended by revoking the Third Schedule, and substituting the Third Schedule as set out in the Schedule to these regulations.


