

AN ACT

To amend sections 2 and 3 of Public Law No. 4-92, Kosrae State public projects, to increase the funds provided to the Kosrae State Improvement Project Commission; to delete subsection (7) of section 2; to decrease the funds appropriated for the congressional delegation office; to appropriate funds for Community Group Goodwill Trips; to renumber subsections (8), (9), (10), and (11) of section 2; to change the allottee of statewide projects; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-92 is hereby amended
2 to read as follows:

3 "Section 2. The sum appropriated under section 1 of this
4 act shall be apportioned as follows:

15 Section 2. Section 3 of Public Law No. 4-92 is hereby amended to
16 read as follows:

17 "Section 3. All funds appropriated by this act shall be
18 allotted, managed, administered, and accounted for in accordance
19 with applicable law, including, but not limited to, the
20 Financial Management Act of 1979. The allottee shall be the
21 chairman of the Kosrae State Improvement Project Commission for
22 all the appropriations herein, except for appropriations
23 under subsections (6), (7), (8), (9), (10), and (11) of
24 section 2. The allottee of funds appropriated under subsection
25 (7) of section 2 shall be the chairman of the board of KICA.

1 The allottee of funds appropriated under subsections (8) and
2 (11) of section 2 shall be the chairman of the Kosrae
3 congressional delegation. The allottee of funds appropriated
4 under subsections (6), (9), and (10) of section 2 shall be the
5 Governor of the State of Kosrae. The allottees shall be
6 responsible for ensuring that these funds, or so much thereof
7 as may be necessary, are used solely for the purposes specified
8 in this act, and that no obligations are incurred in excess
9 of the sum appropriated. The authority of the allottees to
10 obligate funds appropriated by this act shall remain effective
11 until all funds are fully expended."

12 Section 3. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its becoming
14 law without such approval.


