

## AN ACT

To amend Public Law No. 5-15 by amending sections, 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 and 14 and adding new sections 12 and 13 for the purposes of appropriating \$13,005,917 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, as supplemental funding for the National budget; adjusting employment ceilings; shifting funds to accommodate the new accounting system of the Department of Finance and the States; shifting funds and personnel and adjusting lapse dates to accommodate reorganization of the National Government; by renumbering sections 13 and 15; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 5-15 is hereby amended to

24                   (2) The number of positions authorized applies individually  
25 to each of the departments and offices of the executive and

1 legislative branches, the National judiciary, the Public Auditor,  
2 and to the agencies as provided in subsection (1) of this  
3 section, except that the President may transfer up to 12  
4 positions between the departments and offices of the executive  
5 branch. This authorization of positions covers all permanent  
6 employees, all contract personnel whose employment extends for  
7 1 year or more, and all positions funded from United States  
8 federal programs. No funds may be expended for unbudgeted  
9 positions."

10 Section 15. Section 14 of Public Law No. 5-15 is hereby amended to  
11 read as follows:

12 "Section 16. Allotment and management of funds and lapse date.  
13 All funds appropriated by this act shall be allotted, managed,  
14 administered, and accounted for in accordance with applicable  
15 law, including, but not limited to, the Financial Management Act  
16 of 1979, as amended. Each allottee shall be responsible for  
17 ensuring that these funds, or so much thereof as may be  
18 necessary, are used solely for the purposes specified in this  
19 act, and that no obligations are incurred in excess of the sum  
20 appropriated. The authority of the allottees to obligate funds  
21 appropriated by this act shall lapse as of September 30, 1988;  
22 PROVIDED, however, that the authority of the allottees to  
23 obligate funds appropriated by subsections (6), (7), (12) and  
24 (13) of section 1 of this act and subsections (1), (7), (9) and  
25 (10) of section 5 of this act shall lapse as of December 31, 1987."

5 such approval.


