FIFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

SECOND SPECIAL SESSION, 1987

CONGRESSIONAL BILL NO. 5-222, C.D.1

AN ACT

To further amend Public Law No. 5-15, as amended by Public Law No. 5-28, by further amending section 2, as amended by Public Law No. 5-28, for the purpose of appropriating the sum of \$20,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, as supplemental representation funding for the Congress of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 5-15, as amended by Public
2 Law No. 5-28, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the legislative branch.

4 The sum of \$2,092,566, or so much thereof as may be necessary,
5 is hereby appropriated from the General Fund of the Federated
6 States of Micronesia for the fiscal year ending September 30,
7 1988, for the operations of the legislative branch of the
8 National Government of the Federated States of Micronesia during
9 fiscal year 1988. The sum appropriated by this section shall be
10 apportioned as follows:
