AN ACT

To further amend Public Law No. 5-15, as amended by Public Laws Nos. 5-28, 5-45, and 5-48, by further amending section 16, as amended by Public Laws Nos. 5-28 and 5-48, to extend the lapse date for funds earmarked for the conduct of a public census, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 16 of Public Law No. 5-15, as amended by
2 Public Laws Nos. 5-28 and 5-48, is hereby further amended to read as
3 follows:

4 "Section 16. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be allotted,
6 managed, administered, and accounted for in accordance with
7 applicable law, including, but not limited to, the Financial
8 Management Act of 1979, as amended. Each allottee shall be
9 responsible for ensuring that these funds, or so much
10 thereof as may be necessary, are used solely for the
11 purposes specified in this act, and that no obligations are
12 incurred in excess of the sum appropriated. The authority
13 of the allottees to obligate funds appropriated by this act
14 shall lapse as of September 30, 1988; PROVIDED, however,
15 that the authority of the allottees to obligate funds
16 appropriated by subsections (6), (7), (12) and (13) of
17 section 1 of this act and subsections (1), (7), (9) and
18 (10) of section 5 of this act shall lapse as of December
19 31, 1987; PROVIDED FURTHER, however, that the authority of
20 the allottees to obligate funds appropriated by subsection
21 (5) of section 3 of this act and subsection (3)(i) of
22 section 11 of this act shall lapse as of September 30, 1989;



22 section 11 of this act shall lapse as of September 30, 1989;


