FOURTH REGULAR SESSION, 1988

CONGRESSIONAL BILL No. 5-374, C.D.1,
C.D.2, C.D.3

AN ACT

To further amend Public Law No. 4-95, as amended, by further amending section 2, as amended by Public Laws Nos. 4-113, 5-14, 5-30, 5-44, 5-51 and 5-82, for the purpose of changing the use of funds for certain public projects in Truk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
