Public Law No. 6 - 55

AN ACT

To amend Public Law No. 6-49 by amending sections 1, 2, 4, and 6 to apportion the funds appropriated therein, by amending sections 3 and 5 to change the amount and use of funds appropriated thereunder, by adding new sections 7, 8 and 9, by amending section 7 to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 6-49 is hereby amended to
2 read as follows:

3 "Section 1. Statewide public projects. The sum of \$200,000,
4 or so much thereof as may be necessary, is hereby appro-
5 priated from the General Fund of the Federated States of
6 Micronesia for the fiscal year ending September 30, 1990,
7 for the purpose of funding certain statewide public projects
8 in Chuuk State. The sum appropriated by this section shall
9 be apportioned as follows:


18 Section 10. Section 7 of Public Law No. 6-49 is hereby amended
19 to read as follows:

20 "Section 10. Allotment and management of funds and lapse
21 date. All funds appropriated by this act shall be
22 allotted, managed, administered, and accounted for in
23 accordance with applicable law, including, but not limited
24 to, the Financial Management Act of 1979. The allottee of
25 the funds appropriated by section 4 of this act shall be

1 the President of the Federated States of Micronesia.
2 The allottee of the funds appropriated by subsection (2) of
3 section 1 of this act shall be the Truk Organization of
4 Community Action (TOCA); the allottee of the funds
5 appropriated by subsection (4) of section 1 shall
6 be the Lower Mortlocks Development Authority; and the
7 allottee of the funds appropriated by subsections (1), (3),
8 (5), (6), (7), (8), (9), (10), and 11 of section 1 shall
9 be the Governor of Chuuk State. The allottees of the funds
10 appropriated by sections 2, 3, 5, 6, 7, 8 and 9 of this act
11 shall be the local development authorities of the areas for
12 which the projects are designated. The allottees shall be
13 responsible for ensuring that these funds, or so much
14 thereof as may be necessary, are used solely for the
15 purposes specified in this act, and that no obligations are
16 incurred in excess of the sum appropriated. The authority
17 of the allottees to obligate funds appropriated by this act
18 shall not lapse until expended."

19 Section 11. This act shall become law upon approval by the
20 President of the Federated States of Micronesia or upon its becoming
21 law without such approval.
