

AN ACT

To appropriate the sum of \$2,020,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding education and health related projects and programs in the States of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Teacher training. The sum of \$520,000, or so much  
2 thereof as may be necessary, is hereby appropriated from the General  
3 Fund of the Federated States of Micronesia for the fiscal year  
4 ending September 30, 1990, for the purpose of funding elementary  
5 and secondary teacher training in each of the States of the Federated  
6 States of Micronesia. The sum appropriated by this section shall  
7 be apportioned as follows:

- 8 (1) Kosrae .....\$ 80,000
- 9 (2) Yap ..... 110,000
- 10 (3) Chuuk ..... 200,000
- 11 (4) Pohnpei ..... 130,000

12 Section 2. Elementary and secondary education related projects  
13 and programs in Chuuk. The sum of \$525,000, or so much thereof  
14 as may be necessary, is hereby appropriated from the General  
15 Fund of the Federated States of Micronesia for the fiscal year ending  
16 September 30, 1990, for the purpose of funding elementary and  
17 secondary education related projects and programs in Chuuk State.  
18 The sum appropriated by this section shall be apportioned as  
19 follows:

- 20 (1) Southern Namoneas Junior High  
21 School .....\$150,000
- 22 (2) Wonei Elementary School ..... 150,000

1	(3) Northern Namoneas Junior High	
2	School .....	\$ 100,000
3	(4) Purchase of school sites in Fananu.....	50,000
4	(5) Mortlocks Junior High School .....	50,000

7       Section 3. Elementary and secondary education related projects  
8 and programs in Yap. The sum of \$250,000, or so much thereof as may  
9 be necessary, is hereby appropriated from the General Fund of the  
10 Federated States of Micronesia for the fiscal year ending September  
11 30, 1990, for the purpose of funding elementary and secondary  
12 education related projects and programs in Yap State.

13       Section 4. Elementary and secondary education related projects  
14 and programs in Pohnpei. The sum of \$525,000, or so much thereof as  
15 may be necessary, is hereby appropriated from the General Fund of the  
16 Federated States of Micronesia for the fiscal year ending September  
17 30, 1990, for the purpose of funding elementary and secondary  
18 education and senior citizen health related projects and programs in  
19 Pohnpei State. The sum appropriated by this section shall be  
20 apportioned as follows:

21	(1) Senior citizen geriatrics program .....	\$ 50,000
22	(2) Elementary and secondary education related	
23	projects and programs .....	475,000

24       Section 5. Elementary and secondary education related projects  
25 and programs in Kosrae. The sum of \$200,000, or so much thereof as

1 may be necessary, is hereby appropriated from the General Fund of the  
2 Federated States of Micronesia for the fiscal year ending September  
3 30, 1990, for the purpose of funding elementary and secondary  
4 education related projects and programs in Kosrae State. The sum  
5 appropriated by this section shall be apportioned as follows:



13 Section 6. All funds appropriated by this act shall be  
14 allotted, managed, administered, and accounted for in accordance with  
15 applicable law, including, but not limited to, the Financial  
16 Management Act of 1979. The allottee for the funds appropriated  
17 under section 1(1), sections 5(1) and 5(2) of this act shall be the  
18 Governor of Kosrae State. The allottee for the funds appropriated  
19 under section 5(3) shall be the Mayor of Lelu. The allottee for the  
20 funds appropriated under sections 5(4) and 5(7) of this act shall be  
21 the Mayor of Tafunsak. The allottee for the funds appropriated under  
22 section 5(5) of this act shall be the Mayor of Malem. The allottee  
23 for the funds appropriated under section 5(6) of this act shall be  
24 the Mayor of Utwe. The allottee for the funds appropriated under  
25 section 1(2) and section 3 of this act shall be the Governor of Yap

1 State. The allottee for the funds appropriated under section 1(4) and  
2 section 4 of this act shall be the Governor of Pohnpei State. The  
3 allottee for the funds appropriated under section 1(3) and sections 2  
4 (2), (3), (4), (5), and (6) of this act shall be the Governor of  
5 Chuuk State. The allottee for the funds appropriated under section  
6 2(1) of this act shall be the Southern Namoneas Development Authority.  
7 The allottees shall be responsible for ensuring that these funds, or  
8 so much thereof as may be necessary, are used solely for the purposes  
9 specified in this act, and that no obligations are incurred in excess  
10 of the sum appropriated. The authority of the allottees to obligate  
11 funds appropriated by this act shall not lapse.

12 Section 7. Effective date. This act shall become law upon  
13 approval by the President of the Federated States of Micronesia or  
14 upon its becoming law without such approval.
