AN ACT

To provide for the withdrawal and expenditure of moneys from the Treasury Fund and the Nauru Housing Fund in payment for goods and services obtained or ordered for the Republic during the financial year ending on the thirtieth day of June, One thousand nine hundred and seventy-eight.

(Certified: 1st January, 1978)

Enacted by the Parliament of Nauru as follows:

SHORT TITLE

1. This Act may be cited as the Appropriation Act 1977–1978.

INTERPRETATION

2. In this Act—

"Estimates" means the Estimates of the revenues and expenditure of Nauru for the financial year ending on the thirtieth day of June, One thousand nine hundred and seventy-eight prepared and laid before Parliament, in pursuance of Article 59(4) of the Constitution of Nauru.

WITHDRAWAL OF MONEYS FROM THE TREASURY FUND

- 3. (1) The amount of Thirty-five million eight hundred and seventy-seven thousand dollars (\$35,877,000) may be withdrawn from the Treasury Fund and expended as authorised in the Schedule to this Act and in accordance with the Estimates in payment for goods and services obtained or ordered for the Republic during the financial year ending on the thirtieth day of June, One thousand nine hundred and seventy-eight.
- (2) Where the Cabinet considers it necessary to increase the amount assigned in the Estimates to a particular Account within a department, the Cabinet may direct that there shall be applied to the aid of that Account a further sum out of any surplus arising on any other Account within the same department, but so that the total amount withdrawn and expended does not exceed the amount authorised for that department in the Schedule to this Act;

Provided that where the Cabinet authorises a transfer of funds between Accounts within a department in accordance with this subsection, it shall cause to be laid before Parliament at the first meeting of Parliament after it has approved the transfer, a copy of the order of the Cabinet approving such transfer.

NAURU HOUSING FUND

4. Where moneys are withdrawn from the Treasury Fund and expended as authorised in the Schedule to this Act and in accordance with the estimates for the erection, maintenance

and repair of Nauruan housing, the Treasury Fund shall be reimbursed from the Nauru Housing Fund to the extent of that expenditure and the Nauru Housing Fund is hereby charged accordingly.

SUPPLY ACTS

5. (1) The Supply Act 1977 and the Supply (No. 2) Act 1977 are hereby repealed.
(2) Where moneys have been expended in accordance with either of the Acts mentioned in subsection (1), they shall be deemed to have been expended pursuant to this Act.
