## ELECTORAL ACT 1965 - 1973

By-election for the Constituency of Yaren in the Parliament of the Republic of Nauru.

I, SIMON GILLETT, being the duly appointed Returning Officer for the by-election for a member of the Parliament of Nauru for the Constituency of Yaren on 28th August, 1976, hereby make the following declaration in pursuance of the provisions of Section 27(1)(b) of the Electoral Act 1965 - 1973:

### No. of First Preference Votes

No candidate having received an absolute majority of first preference votes, a second, third, fourth and fifth count was made, the ballot papers allocated to the candidates who received the fewest votes on each occasion being re-allocated to the candidate next in order of the electors preference.

As a result, on completion of the fifth count, the total number of first, second, third, fourth and fifth preference votes received by candidates was as follows:

Leo Depagadogi Keke	66
John Ebonoaiye Akubor	50

Having received an absolute majority of the votes, LEO DEPAGADOGI KEKE is elected.
