- The details of these duties are included in the Hostesses' Manual which will be supplied and which may be amended from time to time.
- May be required to undertake other related work and to relieve or stand in for other staff when not specifically rostered for the above duties.
- Qualifications: Applicants must :
- (a) be eighteen years of age and over
  - (b) have a flair for performing the job as mentioned
  - (c) willing to undergo training as Air Hostesses in Nauru and overseas.

General: Training will be given in Nauru, with the exception of some particular procedures which will be undertaken either in Australia or New Zealand.

While undergoing overseas training, accommodation and subsistence allowance will be provided. After completion of the probationary period successfully by the trainees, they will be appointed as Air Hostess by Air Nauru on Commencing salaries as mentioned above.
