CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS

OF GOVERNMENT

IN EXERCISE of the powers in that behalf vested in His Excellency The President, under Article 23 of the Constitution of Nauru, I, KENAS AROI, being the Minister exercising the functions of His Excellency the President in Nauru under and by virtue of appointment as such by cabinet under Article 21 of the Constitution of Nauru, hereby assign to the Minister of the Cabinet of Nauru, as set out below the responsibilities of the Business of the Government of Nauru as set out opposite his name:

MINISTER OF CABINET

MINISTER FOR JUSTICE

BUSINESS OF GOVERNMENT

The portfolio of the Minister for Island Development and Industry in relation to the Business of Government to be undertaken in Nauru by the said Minister.

The assignment of the business of the Government of Nauru as set out above is in addition to and not in substitution for the Business of the Government of Nauru already assigned to the said Minister. The above assignment of responsibility for the Business of Government shall be effective during the absence from the Republic of His Excellency President Hammer DeRoburt, G.C.M.G., O.B.E., M.P.

- (c) to issue civil process, if authorized by rules of court;
- (d) to maintain case files and registers, to record judgements and orders of the District Court and to make, or cause to be made, copies of proceedings where required to do so;
- (e) to receive all fees, fines and penalties, and all other moneys paid or deposited in respect of proceedings in the District Court, and to keep an account of them;
- (f) to perform, or cause to be performed, such other duties connected with the District Court as may be assigned to him by the Resident Magistrate.

B) Family Courts Act 1973, Section 25;

- (a) to attend such sittings of the Court as the Chairman may direct;
- (b) to prepare summonses, warrants, decrees, orders, recognizances; writs of execution and other documents and to submit them to the Chairman or, if the Chairman so directs, to another member of the Court, for signature;
- (c) to issue process, if authorised by rules of court;
- (d) to maintain case files and registers. to record judgements and orders of the Court and to make, or cause to be made copies of proceedings when required to do so;

- (e) to receive all fees, fines and penalties, and all other moneys paid or deposited in respect of proceedings in the Court, and to keep an account of them;
 - (f) to perform, or cause to be performed, such other duties connected with the Court as may be assigned to him by the Chairman.
- C) Inquest Rules 1977, Rule 2:
- 1) The Clerk of the District Court shall keep an indexed register of all deaths reported to the Resident Magistrate under paragraph (b) of subsection (1) of section 4 of the Act; the register shall contain the particulars specified in the First Schedule to these Rules.
 - 2) The Clerk of the District Court shall keep an indexed register of all inquests held by the Resident Magistrate under the Act; the register shall contain the particulars specified in the Second Schedule to these Rules.

QUALIFICATIONS:

Reasonable educational standards with ability to speak and interpret both Nauruan and English.

Knowledge of Court practice and procedures would be an advantage.

Applications should be lodged in writing stating name, age, education and experience with the Chief Secretary before 4.30 p.m. on Friday, 2nd August, 1985.
