REORGANISATION OF DIRECTORATE OF HEALTH & MEDICAL SERVICES

IT IS NOTIFIED for general information that it has been decided to reorganise the existing Directorate of Health & Medical Services in the Department of Health & Education as follows:-

The existing position of the Director of Health & Medical Services is abolished and replaced by two new positions, one position of the Director of Health Services and one position of the Director of Medical Services. The Director of Health Services will have the overall responsibility in respect of Community Health Care, Preventive Services, Health Inspectors, and Dental Services. The Director of Medical Services will have the overall responsibility in respect of Out-Patient and Casualty Services, Curative and Consultancy Services, Laboratory Services, Nursing Services, and Radiographical Services. The Executive Officer, responsible to both the Directors (in respect of their respective fields of responsibility) will be in-charge of Clerical Services, Purchasing and Financial Control, Records and Statistics, Staff and In-Services Training, Patient Services including Catering In-House Services, Pharmaceutical Services and Medical Stores, M.R. - Plant Equipment, Buildings and Furniture.

Pending formal approval by the Minister responsible for the Public Service of alterations of classification, designation and reorganisation of positions currently established under the Directorate of Health and Medical Services pursuant to Section 15 of the Public Service Act 1961-1979, HIS EXCELLENCY BERNARD DOWIYOGO, M.P. President and Minister responsible for the Public Service, has, with immediate effect, approved the establishment of one position of Director of Health Service, and one position of Director of Medical Services. The establishment of these two positions, in place of the current position of the Director of Health and Medical Services, is effective from 29th January, 1990.

Dr. Kiki Thoma has been appointed to the new position of Director of Health Services, and Dr. Godfrey Waidabu to the new position of Director of Medical Services.
