DECLARATION OF RESULT

As a result, the number of first, second or third preference votes allocated to each of the remaining three candidates were as follows:

E. No candidate having received an absolute majority of first, second and third preference votes a fourth count was made of the ballot papers showing Mr. Valdon Stanley Dowiyogo as first, second or third preference, allocating such ballot papers according to the second, third or fourth preferences shown.

As a result, the number of first, second, third or fourth preference votes allocated to each of the remaining two candidates were as follow:-

1.	Nelson De-Burma Tamakin	75
2.	Lui Eoaeo	54
