**ASSIGNMENT OF RESPONSIBILITY FOR THE**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE **HON. DR. KIEREN KEKE M.P.**, BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE TWENTY-SEVENTH MAY, TWO THOUSAND AND EIGHT UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT, HON. MARCUS STEPHEN, M.P.
