**CONSTITUTION OF NAURU
ARTICLE 21**

**ASSIGNMENT OF RESPONSIBILITY FOR THE
BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HON. DR. KIEREN KEKE, M.P., BEING A MEMBER OF THE CABINET OF NAURU TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU, EFFECTIVE EIGHTEENTH DAY OF SEPTEMBER, TWO THOUSAND AND NINE, UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT.
