ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

DAVID ADEANG, M.P. MINISTER ASSISTING THE PRESIDENT OR THE RETURN OF HIS EXCELLENCY THE PRESIDENT HON. BARON DIVAVESI WAQA, M.P.
