**GOVERNMENT PROCUREMENT AND EXEMPTION ARRANGEMENTS ORDER 2024**

Pursuant to *Sections 15B and 15C* of the *Public Finance (Control and Management) Act 1997*, and *Article 17 (1)* of the Constitution of Nauru, the Cabinet has concurred in writing on the 12<sup>th</sup> July, 2024 of the following:

- (1) to revoke all the previous procurement arrangements for goods with immediate effect;
- (2) appoint Eigigu Procurement Limited as the sole Procurement agent to procure all goods for the Government, Public Enterprises, Instrumentalities of the Republic and other independent statutory authorities or bodies;
- (3) donor funded goods are exempted from this Order, unless donors do intend to use Eigigu Procurement Limited;
- (4) all other procurement of goods for the Government, Public Enterprises, Instrumentalities of the Republic and other independent statutory authorities or bodies are to be procured through Eigigu Procurement Limited, except where Eigigu Procurement Limited expressly provides to the procurer that it is not in a position to procure the goods;
- (5) for the purposes of paragraph (4), the respective Government, Public Enterprises, Instrumentalities of the Republic and other independent statutory authorities or bodies must seek prior written approval from the Secretary for Finance. Where the Secretary is of the view that the request be allowed, the approval should be in writing provided under this Order; and
- (6) the Eigigu Procurement Limited must continue with the procurement which it has already undertaken pursuant to the Order issued on 23 May 2024.
