DEPORTATION ACT (CAP. 58)

DEPORTATION ORDER-STATEMENT OF FACTS

WHEREAS YOU, STUART KNIGHTS, are a person who was issued with a resident permit under section 8(1) of the *Immigration Act* but such permit has been cancelled and therefore you have ceased to be the holder of a valid visitor's permit or any other permit issued under the *Immigration Act* (Cap. 60), or any other laws of Solomon Islands.

AND WHEREAS your continuing presence in Solomon Islands without any legal authority is contrary to section 11(1) of the Immigration Act and therefore your presence in Solomon Islands is unlawful.

AND WHEREAS YOU have been declared by the Government as an undesirable person under section 11(2)(f) of the Immigration Act on the ground that you have conducted yourself in a manner prejudicial to the peace and good order in Solomon Islands.

AND TAKE NOTICE that the particulars of the facts against you, STUART KNIGHTS or upon which this ORDER is made are as follows—

- 1. That you are a foreign national from United Kingdom of Great Britain and Northern Island.
- 2. That you entered Solomon Islands on or about the 8th day of December 2009 but you continued to reside illegally or without any legal authority in Solomon Islands to date.
- 3. That you were found to have engaged in employment with Dream Time Amusement Centre as a manager which contravened section 18(1)(k) of the *Immigration Act* as read with section 6(2) and section 13 of the *Immigration Act* (Cap.60)
- 4. That your resident permit NO:920/07 under Lawson Associates Ltd. was cancelled by the Director of Immigration on or about the 14th day of December 2009, thereby making your presence in Solomon Islands unlawful pursuant to section 11(1) of the *Immigration Act*.

- That your appeal against the decision of the Director of Immigration to the Honourable Minister for Commerce, Industries, Labour & Immigration pursuant to section 17(1) of the Immigration Act has been considered and rejected by the Honourable Minister and thus you are ordered to leave Solomon Islands.
- That you continue to be employed by Dream Time Amusement 6. Centre without any valid resident permit to reside and enter pursuant to section 8(1) of the Immigration Act is contrary to section 11(1) of the Immigration Act.
- That you have consented to be placed under Police custody 7. pursuant to section 14 of the Immigration Act.

NOW THEREFORE pursuant to section 4(a) of the Deportation Act and having regard to the particulars of facts stated above. I hereby make this Order against you, STUART KNIGHTS, to leave and thereafter to remain out of Solomon Islands.

AND pursuant to section 7(2) of the Deportation Act, I hereby authorise that this order be served on STUART KNIGHTS and to place him on board any ship or aircraft leaving Solomon Islands.

AND I further authorise and direct the Officer-In-Charge of the Honiara Rove Correctional Service or a Police Station in Solomon Islands to detain STUART KNIGHTS until arrangements are completed to place him on board any ship or aircraft.
