### **ELECTRICITY ACT**

(Cap. 128)

## **ELECTRICITY (CHARGES FOR SUPPLY)(NO. 7) REGULATIONS 2023**

I, Hon. Bradley Tovosia Minister for Mines, Energy and Rural Electrification, and I, Hon. Harry Kuma, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act 2007* (Act No. 7 of 2007), on the recommendation of the Authority, make the following Regulations:

#### **1 Citation**

These Regulations may be cited as the *Electricity (Charges for Supply)(No. 7) Regulations 2023*.

#### **2 Commencement**

These Regulations commence in 1 July 2023

#### **3 Definition**

In these Regulations:

“*non-regular customer*” means a customer who owns a generation facility and is connected through a kilowatt metre.

#### **4 Charges for supply of electricity**

The rates of charges for the supply of electricity from Authority public installations:

- (a) for prepaid customers are specified in Schedule 1; and
- (b) for postpaid customers are specified in Schedule 2; and
- (c) for non-regular customers are specified in Schedule 3.

## 5 Repeal

The *Electricity (Charges for supply)(No. 6) Regulations 2023* are repealed.
