HONIARA CITY ACT 1999 (Act No. 2 of 1999)

HONIARA CITY COUNCIL (FEES, RATES AND CHARGES) ORDINANCE 2009

AN ORDINANCE made pursuant to sections 21(1), 23, 34 and 35 of the Honiara City Act 1999 (Act No. 2 of 1999) to provide for the imposition of fees, rates and charges by Honiara City Council, to make consequential amendments to other Ordinances, and for related purposes.

ENACTED by the Honiara City Council as follows

Short title and commencement

1. This Ordinance may be cited as the Honiara City Council (Fees, Rates and Charges) Ordinance 2009 and commences on 1 January 2010.

Fees, rates and charges—general (Schedule 1)

2. The fees, rates and charges set out in Schedule 1 are imposed with respect to the corresponding service, facility, licence, permit or function specified in that Schedule.

Ref to ate fees" in other Ordinances

3. Where any fee, rate or charge in Schedule 1 includes a reference to a provision of another Ordinance, the fee, rate or charge is the appropriate fee, rate or charge for the purposes of that provision.

Business licences (Schedule 2)

- 4. For the purposes of the Honiara City (Licensing of Businesses) Ordinance:
 - (a) a designated business is a business prescribed in Schedule 2; and
 - (b) the appropriate fee for the issue of a business licence is the amount in Schedule 2 that corresponds to the designated business for which the licence is sought.

- 2. Subsection 4(1) of the Honiara City (Hawkers) Ordinance is amended by deleting "as prescribed from time to time by the Council by resolution".

The Table of Fees inserted after section 8 by GN 200/1995 titled 'Hawkers' Licence Fees' is repealed.

Amendments to Honiara City (Dogs) Ordinance

- 6. Section 18 of the Honiara City (Refuse Disposal) Ordinance is repealed.
- 7. The First Schedule and the Second Schedule to the Honiara City (Refuse Disposal) Ordinance are repealed.

Amendments to the Honiara City (Licensing of Businesses) Ordinance

- 1. Section 2 of the Honiara City (Licensing of Businesses) Ordinance is amended:
 - (a) by repealing the definition of appropriate fee and substituting the following definition—
 - ""appropriate fee" means any fee prescribed in the Honiara City Council (Fees, Rates and Charges) Ordinance 2009 for the purposes of the provision in which the term appears."
 - (b) by repealing the definition of "bakery".
 - (c) by repealing the definition of "designated business" and substituting the following definition
 - ""Designated business" means any business prescribed in the Honiara City Council (Fees, Rates and Charges) Ordinance for the purposes of this Ordinance."
- 2. Subsection 4(1) of the Honiara City (Licensing of Businesses) Ordinance is amended by deleting "prescribed in the Schedule to these By-laws".

- 3. Section 7 of the Honiara City (Licensing of Businesses) Ordinance is amended by deleting "prescribed in the Schedule to these By-laws".
- 4. Section 8 of the Honiara City (Licensing of Businesses) Ordinance is amended by deleting: Provided that a store licence shall for the purpose of these By-laws be deemed to authorise the carrying on of business as a tailor and the business of a bakery in addition to the business of a store".
- 5. The Schedule to the Honiara City (Licensing of Businesses) Ordinance is repealed.
