| Short title and Commencement | 1. | The Ordinance shall be known as the Makira Ulawa Province Supplementary Appropriation Ordinance 2014/2015 and shall come into force upon approval by the Minister of Provincial Government & Institutional Strengthening in accordance with Section 35 of the Provincial Government Act 1997. |
| Authorisation of issuance of \$160,000.00 from the Provincial Fund | 2. | The Appropriation from the Provincial Fund is hereby authorized for the Sum of One Hundred and Sixty Thousand Dollars to be applied for the purpose specified in Subsection 36 of the Provincial Government Act, and to the Service of the Financial Year ending 31st March 2015. |
| Appropriation | 3. | The sum specified in the preceding section shall be appropriated for the supply of the Head(s) specified and in the amounts respectively in relation thereto in schedule to this bill. |
