THE MAKIRA ULAWA PROVINCE SUPPLEMENTARY APPROPRIATION ORDINANCE 2014

Short title and Commencement 1.

The Ordinance shall be known as the Makira Ulawa Province Supplementary Appropriation Ordinance 2014/2015 and shall come into force upon approval by the Minister of Provincial Government & Institutional Strengthening in accordance with Section 35 of the Provincial Government Act 1997.
