PROVINCIAL GOVERNMENT ACT 1997 (No. 7 of 1997)

The Western Province 2006/2007 Appropriation Ordinance

Enacted by the Western Provincial Assembly with Assent of the Minister as follows:

	This Ordinance shall be entitled "Western Province 2006/2007 Appropriation Ordinance" and shall come into force by being passed by the Assembly and Assented to by the Minister in accordance with Section 30 of the Provincial Government Act 1997 and Publication in the Solomon Islands Gazette.

The Appropriation from the Provincial Fund is hereby Authorised the sum of Twenty Two Million Two Hundred and Thirty Seven Thousand, Four Hundred and Seventy Two Dollars for Recurrent, Capital and Development Expenditures to be applied for the purposes specified in section 34(2) of the Provincial
