PRICE CONTROL ACT
(NO. 6 OF 1982)

THE PRICE CONTROL (APPLICATION TO GOODS AND
RESTRICTION OF PRICES) (AMENDMENT) (NO.4)
ORDER 1996

IN exercise of the powers conferred by sections 4 and 6 of the Price Control Act, 1982, and after consultation with the Prices Advisory Committee, The Minister of Finance, hereby makes the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 4) Order, 1996, and shall come into effect on 16 August 1996.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987* is hereby amended by deleting serial No. 13 thereof and substituting therefore the following -

“ 13 PETROLEUM PRODUCTS
