OF SERVICE) ACT 1987
(No. 22 of 1987)**

**THE CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS
OF SERVICE) (CONSTITUTIONAL COMMISSIONS STANDARD
RATE) (AMENDMENT) REGULATIONS 1997**

IN exercise of the powers conferred by section 3 of the Constitutional Offices (Terms and Conditions of Service) Act 1987, the Prime Minister hereby makes the following regulations -

1. These Regulations may be cited as the Constitutional Offices (Terms and Conditions of Service) (Constitutional Commissions Standard Rate) (Amendment) Regulations 1997.

2. The Constitutional Offices (Terms and Conditions of Service) (Constitutional Commissions Standard Rate) Regulations 1994* are hereby amended in paragraph 2 by deleting the rate "\$150.00" that appears therein and substituting therefor the rate "\$250.00"

THE FISHERIES ACT 1972
(No. 13 of 1972)

THE FISHERIES (AMENDMENT) REGULATIONS 1997

IN exercise of the powers conferred by section 20 of the Fisheries Act, 1972, I, VICTOR NGELE, Minister of Agriculture and Fisheries, do hereby make the following Regulations -

Citation

1. These Regulations may be cited as the Fisheries (Amendment) Regulations 1997.

Amendment to regulation 9A

2. The Fisheries Regulations 1972 (hereinafter referred to as the "principal Regulations) is hereby amended by deleting sub-paragraph (2) of regulation 9A.

Amendment to regulation 10A

3. Regulation 10A of the principal Regulations is hereby amended by deleting sub regulation (2) thereof and substituting therefor a new sub-regulation (2) -

" (2) Any person who takes turtles or turtle eggs, destroys or causes to be destroyed turtles, turtle eggs or turtle nests during the breeding seasons which are from June to August and November to January shall be guilty of an offence and liable on conviction to a fine of one hundred dollars or sentenced to three month imprisonment or to both such fine or imprisonment.

Insertion of new regulation 9

4. The principal Regulations is hereby amended by inserting immediately after regulation 18 the following new regulation 19 -

"Discharge 19. (1) No fishing vessel whether foreign or local shall discharge waste water, bilge oil, brine or general garbage into the sea at any ports in the country.

ports. (2) Any fishing vessel that is convicted of the above offence is liable to a fine of one hundred dollars or imprisonment for a period of three months or to both such fine and imprisonment.

5. The Second Schedule to the principal Act is hereby amended by deleting "Form 5" appearing therein and substituting therefor the following new "Form 5" -
