**FOREST RESOURCES AND TIMBER UTILISATION ACT
(Cap. 40)****FOREST RESOURCES AND TIMBER UTILISATION
(EXEMPTION) (BARASIPO LAND) ORDER 2011**

IN exercise of the powers conferred upon me by section 4(1) (c) of the Act, I make this Order –

Citation and commencement

1. This Order may be cited as the Forest Resources and Timber Utilisation (Exemption) (Barasipo Land Order 2011, and commences on the date of publication in the *Gazette*.

Felling and removal of trees

2. (1) The felling of trees and removal of timber and timber products from an area approved under subparagraph (2) in the Barasipo land on, Parara Island in Western Province for the purposes of agricultural development and reforestation on Barasipo land are exempted from the provisions of section 4 of the Act.

(2) No clear felling shall be undertaken under subparagraph (1) unless the Commissioner gives prior written approval of the area to be cleared subject to the following conditions –

- (a) the area to be cleared for agricultural development and reforestation to be clearly marked on a map given to the Commissioner, which shall not at any one time exceed five hundred [500] hectares;
- (b) no extension for additional area to be cleared to be granted until the agricultural development or reforestation has been done in the approved area already cleared to the satisfaction of the Commissioner and the Ministry responsible for Agriculture;

- (c) other conditions necessary to implement the agricultural development or reforestation, as the Commissioner may impose;

(3) A person who contravenes this paragraph is deemed to have committed an offence under section 4 of the Act, as if the exemption were not granted under this Order.

DECLARATION OF UNDESIRABLE IMMIGRANTS

IN exercise of the powers conferred upon me by section 11(2)(f) of the Immigration Act, I hereby order and declare –

Frank Sheng Song CI
Patrick Zhao Quan Zhang
Wong Chin Li
Zhang Tongzi
Liang Ye**

to be undesirable immigrants and their presence or re-entry into Solomon Islands shall be unlawful.

AND I further authorized and direct the Officer-In-Charge of the Honiara ROVE Correctional Service on a Police Station in Solomon Islands to detain **Wei Xian Sen, Frank Sheng Song CI, Patrick Shao Quan Zhang, Wong Chin Li, Zhang Tongzi, Liang Ye**

The Declaration of Undesirable Immigrants made and published as Gazette Notice No. 303 of 2011 on the first November 2011 is hereby revoked.

**DEPORTATION ACT
(Cap. 58)**

DEPORTATION ORDER—STATEMENT OF FACTS

WHEREAS YOU, WEI XIANSEN, WONG CHIN LI, AND ZHANG TONGZI, LIANG YE are persons issued with resident permit under section 8(1) of the Immigration Act, but such permit has been cancelled and therefore you have ceased to be holders of valid resident permits or any such permits issued under the Immigration Act (Cap.60), or any other laws of Solomon Islands.

WHEREAS YOU, FRANK SHENG SONG CI, PATRICK ZHAO QUAN ZHANG are persons issued with Solomon Islands citizenship under section 7(7) of the Citizenship Act (Cap. 57) but such have been confirmed by the Solomon Islands Citizenship Committee Secretary, that you have not granted Solomon Islands citizenship under Solomon Islands Citizenship Act.

AND WHEREAS your continuing declaration as Solomon Islands naturalized citizens under section 7(7) of the Solomon Islands Citizenship Act as Solomon Islands' citizen without a citizenship certificate is contrary to section 7(7) of the Solomon Islands Citizenship Act (Cap. 57) and therefore is unlawful.

AND WHEREAS your continuing presence in Solomon Islands without any legal authority is contrary to section 11(1) of the Immigration Act and therefore your presence in Solomon Islands is unlawful.

AND WHEREAS YOU have been declared as undesirable persons under section 11(2) (f) of the Immigration Act and on the grounds that you have conducted yourselves in such manner prejudicial to the peace and order in Solomon Islands.

AND TAKE NOTICE that the particulars of the facts against you, WEI XIANSEN, WONG CHIN LI, ZHANG TONGZI, LIANG YE, FRANK SHEING SONG CI, PATRICK ZHAO QUAN ZHANG or upon which this ORDER is made as follows –

1. That you Frank Sheng Song CI, a foreign national from China issued with Solomon Islands Passport No. 060037 and confirmed by Solomon Islands Citizenship Committee Secretary that you were not granted with Solomon Islands citizenship status.
 2. That you Patrick Zhao Quan Zhang, a foreign national from China, issued with Solomon Islands Passport No. 060631 and confirmed by Solomon Islands Citizenship Committee Secretary that you were not granted with Solomon Islands citizenship status.
 3. That you Wong Chin Li, Zhang Tongzi, Liang Ye are Malaysian and Chinese nationals.
 4. That you have been found been in possession of beche-de-mer for export contrary to section 13A of the Fisheries Regulation 2009.
 5. That Wong Chin Li resident permit Imm F:975 /94 under Point Cruz Shopping, Wei Xiansen resident permit Imm F: 964/07 under Haiziang Trading Ltd, cancelled by the Director of Immigration thereby making your presence in Solomon Islands unlawful pursuant to section 11(1) of the Immigration Act (Cap. 60).
 6. That you Zhang Tongzi as confirmed by the Royal Solomon Islands Police Force's Crime Statistics and Records of previous convictions that you have been convicted for False Declaration of goods contrary to section 212 of the Customs & Excise Act (Cap. 121) and paid a fine of SBD \$10,000 in default of nine months imprisonment. You also convicted for concealing of goods contrary to section 214 of the same Act, on the 27th of July 2010 at the Central Magistrate Court at Honiara and fined SBD\$2000 in default of 3 months imprisonment.
 7. That you Liang Ye been issued resident permit Imm F: 1179/07 under LSE Company Ltd by the Immigration Authority. The Minister declares Liang Ye is a destitute person after your resident permit Imm F:1179/07 cancelled, thereby making your presence in Solomon Islands unlawful pursuant to section 11(1) of the Immigration Act (Cap. 60).

NOW THEREFORE pursuant to section 4(a) of the Deportation Act and having regard to the particulars of facts stated above, I hereby make this Order against you, WEI XIANSEN, FRANK SHENG SONG CI, PATRICK ZHAO QUAN ZHANG, WONG CHIN LI, ZHANG TONGZI, and LIANG YE, to leave and thereafter to remain out of Solomon Islands.

AND pursuant to section 7(2) of the Deportation Act, I hereby authorise that this order be served on WEIO XIANSEN, FRANK SHENG SONG CI, PATRICK ZHAO QUAN ZHANG, WONG CHIN LI, ZHANG TONGZI, LIANG YE and to place them on board any ship or aircraft leaving Solomon Islands.

AND I further authorise and direct the Officer-In-Charge of the Honiara Rove Correctional Services or a Police Station in Solomon Islands to detain the above persons until arrangements are completed to place them on board any ship or aircraft.
