**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM  
QUARANTINE PERIOD )(NO. 19) ORDER 2020**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 9 of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice 193 of 2020), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 19) Order 2020*.

**2 Commencement**

This Order commences on the day it is published in the Gazette.

**3 Exemption from quarantine period**

- (1) The following persons are exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 6 December 2020, 7 December 2020 and 9 December 2020:
  - (a) Stephen De Maria;
  - (b) Paul Robinson;
  - (c) Susan Jean Henry;
  - (d) Troy Andrew Bayfield;
  - (e) Deborah Denise Rasmussen;
  - (f) Warren Danford Michael.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
  - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
