**Detainee Name:** Moana Kalosil

**Decision:** His application is approved for release on parole on standard and special conditions to remain until 21<sup>st</sup> October 2019.

**Release Condition:** - To be supervised directly by his Probation Officer and to report to his Probation Officer any threats against him for safety reasons.

- To undertake Spiritual Counselling with Pastor Allen Navuki Presbyterian Church as and when arranged by the Probation Services.
- To undertake "Niufala Rod Program" as directed by a Probation officer.
- To Undertake "Corruption Awareness Module" as directed by the Probation officer.
- To make a public apology to the Nation over the media within 7 days and a custom reconciliation to families within 21 days.
- Not to hold public office within the period of ten years or so
- To abstain from any actions directly against any other political groupings.
- Not to re-offend

**Decision:** His application is approved for release on parole to remain until his Sentence End Date on 16<sup>th</sup> March 2019.

**Release Condition:** - Reside at Anamburu area until sentence end date

- Undertake violence and or anger awareness program again to test his responsivity again while in the community
- Undertake spiritual counselling with a Church Leader
- Undertake Niufala Rod Program with his Probation Officer
- Must not re-offend again
- Undertake any rehabilitation programs as organized by the Probation Service.

**Release Date:** Not until after 29<sup>th</sup> October 2017.

**Decision:** His application is approved to be released on parole to remain until his Sentence End Date on 25/09/2019.

- To undertake Niufala Rod Program
- Not to change residence location without prior of the probation
- Note to make any direct or indirect conduct with the victim unless approval of the probation officer
- Must not re-offend
- To reside only at Bellevue.

- To undertake spiritual counselling and undertake any church activities as directed by Probation Officer
- To undertake Niufala Rod Program as directed by Probation Officer
- Not to re-offend or commit other criminal offences.
