JUDGMENT

HISTRI BLONG KES.

Matter blong Erakor jifly title istat long Efate Island Kot taem we olgeta parties ilodgem proper klem blong olgeta blong klemem title ia. Hemia ifolem nomo wan oda we ikam long Supreme Kot we idated long 27 June, 2002 mo we iodarem Efate Island Kot blong finem wan solution long dispute ia. Blong deal wetem Island Court iansarem six kwestin we Supreme Kot iaskem. Afta we Island Kot iharem kes ia mo answarem six fala kwestin we Supreme Kot iaskem, Island Kot iko on blong declarem se Kalmetabil Kalmet Nmak nao hemi rightful jif blong Erakor folem kastom. Decisen blong Island Kot ia ikam aot long 7th August, 2002. Subject long Oda ia, Tufala pati blong Waya TENENE mo Sual KALMARIE ino glad mo applil iko long Senior Magistrate Kot (CC 07/2002). Long namba 7th day blong January, 2003 Senior Magistrate Kot idismissim ol graons blong applil blong olgeta mo konfirmem decisen blong Island Kot. Afta long unsakseful applil



ia oli further applil iko long Supreme kot. Supreme Kot ifurther dismissim applil ia mo maintainem answa blong six kwestin ia we Island Kot iansarem. Supreme Kot imekem wan oda blong imas kat elekSEN blong resolvem dispute ia. Ikat further applil iko long Kot of Appil, mo long namba 7th November 2003, Kot of Appil imaintainem answers blong sixfala kwestins ia mo sendem bak matter ia ikam long Island kot. Issue we Kot of Appeal iodarem Island Kot blong harem hemi;

"The Island Court shall make a determination as to whether holding of an election to choose a Chief is part of the custom of Erakor village and all other outstanding issues which need to be decided in obtaining a new chief of Erakor Village".

Kot ia bifo iko long ol edvidence, kot iwantem mekem iklia long ol parti se hemi no save considerem ol evidences we irelate long ol answers blong six kwestin we Island Kot ibin answaren finis.

Kot ia hemi definem kastom olsem "*rule blong law we ifomem fasin mo conduct blong pipol long wan society we hemi establish bifo finis mo ino replacem any kastom.. Law ia oli no writem daon mo pipol iliv wetem.*"






Siposi eleksen ipat blong kastom blong Erakor then wanem nao kastom blong Erakor blong pasem jif title?

Kot ifinem aot se jif title hemi wan kastom samting we oli pasem aot from wan man iko long nara wan, and hemi kastomary samting we imas pass on folem bladlaen nomo. Taem we eleksen ikam in idisturben wan kastomary fasin we iexist bifo finis istap and icausem raorao nomo kamkasem tedi.

Island kot idil wetem ol' customary matters mo hemi gat mandate olsem highest kastom kot long jurisdiction blong determinem issue long kastom. Nao sabject long ol' powers ia mo olgeta findings blong Efate Island Kot long issue we istap bifo long kot ia, Kot ia istap long wan position blong formally **Declarem se, eleksen hemi no pat blong kastom blong Erakor.**




According long decleration ia, Kot imekem olgeta odas ia:
