Issue:





Mitufala italemaot long honourable Kot ia se nakamal blong Pongsine igat tri (3) ston (navot) long hem (1) beared body blong big chief mo founda blong nakamal ia. Trifala ston or navot imimin:

Nao hemi rescivim wan tribe blong Pentecost we hemi kam stap long nakamal blong Aim festaem then afta ijes muv ikam long Pongsine we taem ia nakamal istap mo laef finis. Mrewla hemi risivim sam tribe blong Sanaliv we oli kam long Pongsine we mifala ikarem sam kastom raet long hem olsem graon nomo we mifala iresivim olketa. 



Ol findings blong Court:

Island Kot iharem ol toktok blong fourfala parti wetem ol witnessis blong olgeta mo fianemaot se ikat sam long ol pati oli no man ples. Kot ifainemaot tu se ikat 2 kaonsel blong ol Jif ibin tekem 2 separate decision finis long matter ia, ikat Walla koansel blong Jif mo Rano Kaonsel blong Jif. Decision ibin ko long 2 different pipol. This Court bae hemi lukluk mo givim decision blong hem base long trial insaet long Kot.

-Family Hilaire Niovenmal yu bin indicate long Kot se yu kam long Pentecost. Kot irespond long yu se yu no man Pongsine nakamal.

-Family Jean Ceriaque yu bin indicate long Kot se yu kam long Pinalum. Kot irespond long yu se yu no man Pongsine nakamal.

-Family Elie Bahormal yu ibin indicatem long Kot se yu kam long Bankir, South Malekula. Kot irespond long yu se yu no man Pongsine nakamal.

-Family Malsrake Joselito yu bin indicatem long Kot se yu smol faea blong Pongsine nakamal.

-Igat family David we Kot inotem se hemi stret blad mo hem nao iman Pongsine nakamal. Hemi stret man blong tekem taetol blong Jif be Court inotem se hemi no gat eni stret pikinini wei bladline blong hem ilaeif istap.

Law we Court I applaem:

CAP 167 (s.10) - Application of customary law

Subject to the Provisions of this Act, an island court shall administer the customary law prevailing within the territorial jurisdiction of the court so far as the same is not in conflict with any written law and is not contrary to justice, morality and good order.

Translate:

CAP 167 (s.10) - Kot hemi mas applaem kastom

Subject long seksei blong Act ia, aelan kot hemi mas aplaem kastom we istap insaed long eria blong paoa blong hem, spos oli no gat conflict wetem eni loa we oli stap raetem, mo no gat konflik tu wetem jastis, morality mo gudfala orda.

Apply Law igo long fact:

Section blong Law we Court ia istap applyem tudei hemia antap- CAP 167 (s.10). Common practice mo custom insaed long nasara ya, long bifo ikam kasem tudei oltaem fes bon son nao hemi stap inheritem title blong Jif. Ino eni fes bon but fes bon follem bladline. Pikinini boe we mama igat bel long hem finis afta ikam in long wan nasara bae pikinini boe ya imas putum hem daon mo kam andanit long authority blong ol stret bladline.

Nara kastom practice tu se man wei kam long nara ples or Island bae ino save karem taetol ia blong ikam wan Jif blong ol pipol, hem oltaem hemi mas kam stap andanit long stret man ples long area ia, we spos big faea inomo gat then bae smol faea inext person we isave tekem rant ia.

Olgeta points ya nao oli ol gudfala orda we hemi ol custom practice blong long taem finis ikam we Court ia tudei bae ifollem.

Las toktok:

Dispute ia hemi causem plante division between olgeta Clemens, Court iwantem se bae peace imas stap ol taem. Eni wan insaed long family we bae itraem blong brekem order ia hemi save pass long Court from contempt blong Court Order or fine or go long kalabus.

DECISION:

Afta we Court iharem ol toktok blong tugeta claimant mo harem ol toktok blong ol witnesses, Court istap mekem declaration olsem:

- Family Malsrake Joselito we hemi smol faea Kot i declared tedei se hem nao ikarem taetol blong paramount Jif long Pongsine Nakamal.

- Sipos eni parti we ino agri long decision ia hemi gat 14 deis blong mekem appeal blong hem igo long higher Court.
