JUDGMENT

Dispute we istap bifo long Kot ia emi concernem raoraon ova long chiefly title ia "Taripoamata" we emi originally blong Siviri village, emia long North Efate. Tufala parties we istap dispute ova long chiefly title ia emi, Chief Peter Masongomapula olsem Claimant mo Eddie Kalowia olsem Defendant.

BACKGROUND BLONG CASE

Efate Island Court ibin sitaon long Siviri village long 20th June 2005 mo handem daon decision blong chiefly title ia Taripoamata mo declaration ia iread olsem;

"Stat tedei, right blong title ia Taripoamata emi stap long hand blong Claimant (Masongomapula) folem bloodline blong Toamiala Taripoamata. Eddie Kalowia emi mas handem ova title ia iko long Claimant long period blong tri (3) manis taem. Tufala part imas mekem reconciliation ceremony between tufala before ordination long niufala chief Taripoamata. Ino kat Oda blong kost. 30 days blong appeal"

Defendant Mr Eddie Kalowia iapil againsem decision ia blong Efate Island Court long Civil Appeal Case No.4 blong 2006, we idated 20th June 2005 mo faelem apil blong em long 22nd July 2005. Long 4th January 2008, Magistrate Court ihandem daon decision blong Civil Appeal Case No.4 blong 2006 mo long wan part blong Judgment ia, Senior Magistrate Steve R Bani iconcludum se;

"This appeal must succeed for two reasons. Firstly it became obvious that the Court below failed to make a decision on the evidence properly adduced before it and secondly, the Court had acted so imprudently, having regard to the manner in which members of the Court conducted themselves"

Ol Orders blong Judgment ia iread;

"The appeal is allowed. The Judgment of the Efate Island Court dated 20th June 2005 is quashed. This matter is remitted to the Efate Island Court to be tried afresh by a differently constituted Court. The Respondent shall bear the costs of this appeal to be fixed by the court failing agreement"

Long 29th October 2008, Chief Magistrate Stephen D Felix emi mekem Direction Orders long Civil Appeal Case No.4 blong 2008 mo long ol findings blong em afta we iharem Mr Daniel Yawah long behalf blong Chief Eddie Kalowia, emi mekem olgeta Orders ia;

"That the Efate Island Court proceeds on the 3rd of November to hear the Civil Case as directed by Order 3 of the Magistrate's Court in its judgment dated January 4th 2008. That the Island Court sitting on the 3rd November 2008 be constituted of three justices other than Justices Anne Carlot, Francis Aru, Thompson Andrew, Jimmy Meameadola, Kalkot Mormor, Raymond Marongoe and Lucy Sandy. That for reasons of security and cost, the sitting shall be at Port Vila at a time and place to be advised by the Island Court Clerk. This appeal matter is adjourned to the 5th of November 2008 for mention.

Kilu Lawyers mo talem se follem Magistrate's Court Order long namba 24th September 2008 ibin ordarem (Order No.6) se bambae re-hearing blong chiefly title dispute blong Taripoamata mbae imas stap long Siviri village from reason se some long ol witnesses oli olfala tumas mo oli nomore save wokbaot strong blong stap kam atendem Court long Vila.

Mo narafala issue se emi blong katem daon cost blong transportation blong ol parties. Mo narafala leta dated 1st June 2009 we ikam long Dr Willie Tokon Medical Services Manager mo leta ia icertifaem se Mr Arthur Tamaro we emi main witness blong case ia blong Taripoamata emi wan patient we regularly istap attendem medical treatment long outpatient emia long Vila Central Hospital. Mo doctor iadvise se emi 95 years mo emi stap kasem treatment blong arthrosclerosis long spine blong em mo emi no fit blong emi stap travel ikam long Vila.

Defendant emi object mo emi talem se olgeta oli no agree blong Court ia iko sitaon long siviri village from during last Court sitting ikat evidence we ishoem se Justices oli stap toktok wetem ol frens blong olgeta mo stap kaikai wetem narafala party. Mo long issue

blong Arthur Tamaro olsem witness, Claimant emi shud save se wan olfala blong 95 years emi nomo fit blong stap kam long Court mo brain blong em inomo save function properly. Medical certificate we doctor imekem emi soem clear se Arthur Tamaro emi nomo fit. Claimant ishud changem witness ia. However, afta we Court iharem ol toktok blong Claimant folem tufala leta mo ol direction Orders we Magistrate's Court imekem, Court ia idecide long namba 2nd June 2009 se, emi more fair blong Court ia isitaon nomo long Vila blong determinem chiefly dispute ia long best interest blong tufala parites. Court iacceptem tu ol niu documents or evidences we tufala parties iwish blong faelem long Court before Court iproceed long trial. Long view blong Court, mifala iluk se witness Arthur Tamaro emi too old mo emi nomo fit blong kam long Court olsem we medical certificate blong doctor icertifaem. However, Court ia iaskem long Claimant blong imas changem witness ia.

Spokesperson blong Claimant, emia askem adjournem blong Court iconvene nomo long namba 3rd June 2009, from reason se mbae oli prepare gud bifo oli presentem case blong olgeta long next day, be defense oli object mo talem se, olgeta oli wastem tumas time mo expenses long ol costs mo time blong olgeta mo olgeta oli redi naowia blong proceed. Spokes person Mr Titus Taripu iaskem sapos Court isave allowem Claimant blong ipresentem history blong em. Court iacceptem request blong defense mo askem Claimant emi agree mo iproceed blong presentem case blong em.

CASE BLONG CLAIMANT

Bifo, Claimant emi presentem case blong emi, emi talem se history blong olgeta ia oli bin presentem finis long Marakinavata council blong ol chiefs long 3rd May 2003 mo long Efate Island Court long Civil Case No.19 blong 2005, long 20th June 2005. Mo same history nomo bakagen mbae mi presentem tedei. Mifala ino changem history blong mifala mo ol evidences blong mifala.

Claimant Masongo Mapula one (1) emi kat wan pikinini boy mo emi kam Masong Mapula 2. Masongo Mapula 1 emi ded long 1819 emia long record blong Missi Peter Milne. Masong Mapula 2 emi maretew wan woman nem blong em Lei Maki mo tufala ikat wan gel nem blong em Lei Mata mo wan boy nem blong em Tomastapangatang or sandwich we Missionary isendem em iko mo ded long Solomon Islands. Lei Mata (naika) emi maretew Toa Miala Taripoamata blong siviri mo ikat three brata, Toa Wia, Toa Miro mo Toa Tau. Toa Wia emi ded mo emi no kat pikinini. Toa Miro emi maret mo kat wan gel we nomo mo nem blong em Tourere we ol family blong em oli live long Moso tedei. Toa Tau emi maret mo ko stap wetem woman blong em long Emua mo ol family blong em oli stap long Emua tedei.

Toa Miala emi karem title ia Taripoamata from ol brata blong emi oli livim em mo ko stap wetem ol woman blong olgeta long Emua village mo Moso Island. Toa Miala Taripoamata mo Leimata tufala ikat wan gel we nem blong em Toulore. Toulore emi maretew Peter Akisi we emi blong ravega. Peter Akisi emi kat wan boy we nem blong em Arthur Tamaro mo tufala sisters blong em, emi Effie mo Vinota. Taem we Arthur Tamoro emi born long 1914, Leimata mo Toa Miala Taripoamata tufala iadoptem Arthur

Tamaro olsem pikinini blong tufala from tufala ino kat pikinini boy blong karem title ia Masong Mapula 3 mo Taripoamata we emi title blong pupu blong em, Toa Miala Taripoamata mo tu from Arthur Tamaro we emi papa blong Claimant emi stret pupu blong tufala. Arthur Tamaro Masongo Mapula 3 emi maret mo kat 5 boys' mo 2 gels. Ol boys ia ikat Chief Masongo mapula 4 we emi Claimant, Paul Arthur, Edwin Arthur, David Arthur, Kaltava Arthur mo tufala gel ikat Tou Mak mo Tou Fau.

Chief Masongo Mapula 4 emi rightful Claimant blong title Taripoamata tru long ol name ia Toa Miala Taripoamata, Toulore mo Arthur Tamaro we emi papa blong claimant mo sem taem claimant emi adopted pikinini blong Toa Miala Taripoamata mo Lei Mata. Peter Akisi we emi pupu blong claimant emi ded long 1923 mo long 1927, Toulor, pupu woman blong claimnant mo Tourere gel blong Toa Miro tufala igivim title Masong Mapula 3 long Arthur Tamaro mo title Taripoamata long Kalosike Joseph Masenmantoga 3, we emi grand papa blong Defendant. Reson we oli kivim title ia long Kalosike emi from we long taem ia Masongo Mapula 3 emi yang iet mo oli mas chosem wan man we emi mature blong save lukaotem pipol blong siviri kasem taem Masong Mapula 3 emi save karem title ia Taripoamata. Mo narafala reason from we Toulore mo Tourere tufala ino wantem Kalo Talang blong karem title blong chief Maripepe blong leadim pipol blong siviri from fasin blong em blong karem plante woman tumas.

Maripepe emi chief we emi lukaotem siviri village taem we ino ikat wan man emi karem chiefly title Masong Mapula mo Taripoamata. Hemia emi long laef time blong Toulore mo Tourere kasem we Masongo Mapula 3 emi kasem title blong em mo Kalosike emi karem title ia Taripoamata. Long taem blong kivim title ia Taripoamata long Kalosike, papa blong em Joseph Suragas Masenmantoga 2 ino kat pig blong givim long pikinini blng em blong performern ceremony mo community blong siviri village oli givim pig long Kalosike Masenmantoga blong kilim. Pig ia siviri community ipem long Masta Louis Ross long Undine bay plantation mo price blong em long taem ia emi 8 pounds. Taem ia 4 man oli karem pig ia from emi hevi tumas. Stret title blong Kalowia emi Masenmantoga 4 be emi no Taripoamata. Long side blong history blong Kalosike, olfala Masenmantoga 1 emi bigfala chief blong ravenga. Emi maretem Vitarik Pero mo kat wan boy we nem blong em, emi Masenmantoga 2, known olsem Suragas Joseph. Masenmantoga 2 emi maretem Lei Ntamate we emi daughter blong chief blong Elama Tongoltong mo Lei Sav Manu. Joseph Suragaas Masenmantoga 2 wetem Lei Ntamate tufala ikat two boys' mo wan gel. First boy blong tufala emi Kalserei we emi sik mo ided mo second boy emi Kalosike mo kat wan gel we nem blong em emi Toulolo. Ikat wan narafala gel we nem blong em, emi Touvapele be emi no stret pikinini blong Joseph Suragas. Kalosike emi maretem Mima mo tufala ikat wan gel we nem blong em, emi Rose mo emi maret iko long Tasiriki. Taem Mima emi ded, Kalosike emi maretem Ruta we emi kat three pikinini finsi bifo emi kam insaed long haos blong Kalosike we nem blong olgeta emi Tamara, Lei Pakoa mo

Lei Mata. Tedei Tamara emi ko bak mo live long Pele Island from emi save se emi no pikinini blong Kalosike. Afta long Ruta, Kalosike emi maretem Espela mo karem Kalowia, Toma, Lili, Lei Tap mo Lei Tare. Taem we Kalosike emi tekem title ia Taripoamata start long 1927, em wan emi save se title ia Taripoamata emi no blong em. Be tufala woman ia Toulore mo Tourere nao igivim long em. Plenty taem Kalosike emi stap talemaot toktok ia long ol meeting se emi no wantem karem title ia be tufala olfala woman ia nomo ikivim long em. Taem we Kalosike emi laef mo stat long 1927 kasem taem we emi ded, long 1988, emi neva appointem Eddie Kalowia or mekem wan ceremony blong Eddie Kalowia emi karem title ia Taripoamata from emi save se title Taripoamata emi no blong em.

Naowia kolosap seventeen yia nao afta long ded blong Kalosike, Eddie Kalowia emi wantem title ia Taripoamata, be why nao emi no save askem papa blong em Kalosike blong givim title ia Taripoamata long em. Toa Miala Taripoamata blong siviri village emi wan chief mo preacher mo em nao emi ko karem Masenmantoga 1 wetem ol man ravenga mo kam putum olgeta long wan ples we nem blong em Matanoaira emia bitwin 1885 mo 1888 mo long 1893, wan bigfala sikness ibreak out mo sam long ol man ravenga we oli stap long Matanoaira mo chief Toa Miala Taripoamata oli ded mo olgeta we oli laef oli move ikam long siviri village wetem Joseph Surangas mo oli ordainem em olsem Masenmantoga 2 wetem ol narafala chiefs long 1927.

Matanoaira emi ground blong chief Toa Miala Taripoamata mo long 1920, Lei Mata emi salem long wan man Pentecost we nem blong em, emi Wari long wan price blong 20 pounds. Mo mi wandem talemaot long honorable Court ia se, stret bloodline blong title ia Taripoamata emi blong Chief Masongo Mapula 4.

Thomas Tapangtang or Thomas Tavangtang or Thomas Sandwich, emia same man nomo, emi ko ded long Solomon, mo mifala irefer long Live book 3 we John Graham Miller iraetem emia long pages 54, 55 mo 56. Nao Leimata we em wan nomo istap emi entaetel long title ia Masongomapula.

Nao fes Taripoamata blong siviri village ikat 4 pikinini. Olgeta ia ikat Toa Wia we mi ded nomo long siviri village mo ino kat pikinini, Toa Miro imared mo ikat wan pikinini gel nomo we nem blong em, emi Tourere we imaretetem William blong Moso Island. Mo

taem we man blong em ia William ided, Tourere emi maret ikam bak long siviri village. Toa Tau emi folem wan woman blong em mo iko long Emua mo ol family blong em oli stap long Emua tedei. Mo Toa Miala Taripoamata ia nao ikarem title ia. Hemia mifala irefer long history blong Masongomapula mo olsem wanem emi entaetel blong karem title ia Taripoamata page 1 emia long statement 3. Toa Miala Taripoamata imaretem Leimata mo tufala ikat wan gel nomo we nem blong em Toulore. Toa Miala Taripoamata blong siviri village iko karem ol family's blong Eddie Kalowia long Ravenga ikam daon long siviri village wetem Peter Akisi. Taem ia nao Peter Akisi imaretem Toulore mo emi kam insaed long family tri blong siviri village. Mo antap long emia Toa Miala Taripoamata ikivim smol pis kraon blong em Matanoaira long olgeta blong Raveng blong live long em.

Claimant iwandem submitim tu se long 5th March tufala chief representative blong Vaturisu Council of Chiefs, Natamatesaru blong Lelepa mo Raymond Marongoe blong Emua tufala nao iordainem Peter Arthur olsem chief Masongomapula 4 mo tu long same day chief Masongomapula 4 emi mekem ordination blong ol smol, smol chiefs blong em.

Olgeta chiefs ia ikat Atavi Maserawota (Kalengoro Steele), chief Masewia (Edwin Arthur), Atavi Tavi Masoe (Kalsau Steele), chief Tarisongololo (Philip Shem) mo chief Manauvea (late Robert Obed). Claimant iwandem talem bakagen se history timeline blong mifala istap confirmem bakagen se history blong mifala istart long 1800 finis, bifo taem missionary istart blong mekem ol wok blong em long Efate. History blong mifala iconfirmen tu se Masongomapula blong siviri village emi stap mekem wok finis long taem ia from missionary irecordem mo Toa family tu oli stap finis long siviri village.

Mifala iwandem submit tu, se witness blong Defendant namba 1 Eddie Kalowia emi no save conectem em, wetem family tri blong em. Emi no save meaning blong siviri, nem blong stone blong siviri, nem blong pasis blong siviri, nem blong tapu ples blong siviri

ino emi no save farea we em mo papa blong em igrow up long em. Rosbel we emi fes born blong Kalosike mo ol stret nephew blong Eddie Kalowia we oli laef istap tedei oli no witness blong em. Mifala iwandem submit se ol witness blong Eddie Kalowia everyone blong narafala village. Mifala iwandem submit tu se why papa blong Eddie Kalowia, chief Kalosike emi no handem ova title Taripoamata iko long Eddie Kalowia taem emi laef yet. From wanem Kalosike Taripoamata ineva raorao long Masongomapula 3 from emi kam live long nasara blong em mo emi caretaker long chiefly title ia Taripoamata.

Arthur Tamaro mo brata blong em James Tapalo tufala ineva raorao wetem Kalosike Taripoamata from title ia we iblong tufala, folem respect we tufala ikat long em from emi bin glad mo acceptem blong upholem wok ia olsem caretaker blong chiefly title ia Taripoamata. Long taem blong ordination, chief Taripoamata emi sidaon long chair mo putum leg blong em long stone. Emia iminim se chiefly title we iholem emi no blong em. Chief Arthur Tamaro iconfirmem form em tu oli bin ordainem em tu long taem ia. Arthur Tamaro ino sitaon long wood olsem statement blong Eddie Kalowia italem. Long kastom blong Efate, taem oli ordainem wan chief, mbae ineva sidaon long wan stone mo stanap long wan narafala stone.

Mifala family blong Masongomapula 3 mo 4 ineva agensem Eddie Kalowia from title ia kasem taem em m family blong em istap agensem mifala ol natakok blong siviri village from title blong mifala Taripoamata. Mifala iwantem some long em se emi wan namenak. Long kastom blong Efate, taem oli ordainem wan chief, mbae emi neva staon long wan stone mo stanap long wan narafala stone. Taem yu pulum wan man iko raon long wan ded bodi blong wan chief, emi minim may be itekem ples blong em wan day or no? Even siros yuk o andanit long ded body blong em we imo hevi, be emia tu isave kam may be yes or may be not? Mifala iwandem submit se ol chief oli jusum ol man blong tekem place blong olgeta folem kind humble heart blong man. Mifala iwandem talem tu se Masongomapula we spokes man blong Eddie Kalowia istap tokbaot emi blong Pele Island (*refer long page 176-177, Peter Milne of Nguna*).

Mifala iwandem talem tu se witness namba 2, blong defendant Mr Tony Firiam emi no save talem stret nem blong ol chiefs we oli present long taem we chief Manabangarasikai ipulum hand blong Eddie Kalowia iko raon long ded body blong late Kaloskie Taripoamata. Witness ia italem se emi luk Morres Manaruru long taem ia, be Claimant iwandem talem se Morres Manaruru emi ded finis long July 1986, two yia bifo we chief Taripoamata ided long 1988. Witness imentionem tu chief Manasakau, mifala isubmit se chief ia tu ided long taem finis. Mifala iwandem submit tu se bisnis blong storian long chiefly title emi no blong public iharem emi blong haos or family nomo ikat raet long em. Witness ia tu ino so sure wanem ia chief Taripoamata Matua mo chief Taripoamata Tokai Tangele tufala ireign.

Malapoamata ia nao chief Masongomapula 4 istap live long em tedei. Masongomapula 4 iko askem permission blong go lukaot stone blong bekem laplap blong ceremony blong ordination from ples ia nomo mifala istap ko tekem ol stone long em.

Witness 4 blong defendant Mr Charley Obed, emi usum different statement long trifala Court case. Hemi usum tu different chiefly title olsem, Monomono mo Masemaduruvakalo, emia isoem se witness ia emi no honest long ol toktok blong em.

Witness 5 blong defendant Mr Takurua Taurasongi Dick emi no save storian or history blong chiefly title ia Taripoamata. Witness ia emi wan pikinini we igrow up olbaot, emi no even save stret history blong em. How nao emi save history blong narafala chief? Witness ia italem se Eddie Kalowia ikleimem title ia follem Leisavimanu we emi wife blong bigfala chief blong Elema, chief Tongoltong. Leisavimanu em Kupenakara. Manatuatuanatokolau (papa blong Tongoltong) ino save go mekem areinjem wetem Taripoamata Tokai Tangele from long taem ia itaem blong tribal war. Statement blong ol narafala witness italem se Taripoamata Tokai Tangele ided long tribal war, be taem long cross-examination witness ia ise emi no save.

Mifala iwandem submit tu se Eddie Kalowia emi no presentem same history blong em long ol last previous court sittings blong mifala aboutem dispute ia. Therefore mi stap askem long this honorable Court ia blong declarem Defendant Eddie Kalowia oslem rightful owner blong chiefly title ia Taripoamata.

LAWS

“Existing Law”

Article 95 (3) provides that customary law shall continue to have effect as part of the law of the Republic of Vanuatu.

“Village and Island Courts”

Article 8 (5) of the Constitution of the Republic of Vanuatu provides that; Parliament shall provide for the establishment of Village or Island Courts with jurisdiction over customary and other matters and shall provide for the role of Chiefs in such Courts.

“Application of Customary Law”

Section 10 of the Island Courts Act, CAP 167, of 1983 provides that; subject to the provisions of this Act an Island Court administer the customary law prevailing within the territorial jurisdiction of the Court so far as the same in not in conflict with any written law and is not contrary to justice, morality and good order.

ISSUE BIFO LONG KOT IA

- Wanem custom fasin nao man ia imas follem blong iinheritim chiefly title ia?
- Who nao emi stret man under long custom rules blong iinheritim custom property ia?

COURT FINDINGS

While Court emi mindful long wanem we Constitution italem long Article 95 (3), 8 (5) mo section 10 blong Island Courts Act CAP 167, Court ia emi redi nao blong applaem olgeta relevant customary rules blong helpem em blong solvem dispute ia. Long taem we ikat wan complaint most long ol taem nao ikat denials we narafala party isave mekem againsem wan statement blong wan complainant and sapos iolsem, mbae Defendant nao emi must oltaem blong mekem defence blong em tru long response mo ol evidences we mbae emi produisum bifo long Court. Long view blong Court ia iluk se, sapos ikat denials long wan statement, then tufala parties imas kivim opportunity blong provum mo disprovum all allegations ia mo producim evidences bifo long Court.

Long case blong Claimant, long family tri, Court ifaenemaot se Masongo Mapula 1 emi kat wan pikinini boy we nem blong em Masongomapula 2. Masongomapula 2 emi maretem wan woman nem blong em Leimaki mo tufala ikat wan gel we nem blong em Leimata. Leimata emi maretem Toa Miala Taripoamata mo tufala ikat three (3) pikinini. Olgeta pikinini blong tufala ikat Toa Wia, Toa Miro mo Toa Tau. Toa Wia emi ded mo emi no kat pikinini. Claimant emi no establishim any evidence blong soem long Court ia,

se Toa Wia emi ded long wea ples mo oli berem em long wea. Court emi interest more long pikinini ia Toa Miala Taripoamata we long family tri Claimant isoem se emi maretem Leimata mo tufala ikat wan gel we nem blong em, emi Toulore. Toulore emi maretem Peter Akisi we emi blong Ravega village mo tufala ikat three (3) pikinini. Trifala pikinini ia emi Arthur Tamaro we emi wan boy mo Effie mo Vinota emi tufala gel. Statement ia ol witnesses blong Claimant oli confirmem taem oli stap testified long Court.

Taem Mima emi ded, Chief Taripoamata emi maretem Ruth mo tufala ino kat pikinini. Tufala iadoptem Tamara, Leimata mo Leipakoa, afta Ruth emi ded.

Afta we Ruth emi ded, Chief Taripoamata emi maretem Isobel mo tufala ikat olgeta pikinini ia, ikat Leisongi, Lily, Leitap, Kalowia Eddie Taripoamata, Tom mo Leitare. Witness namba 2 blong Defendant Tony Firiam emi confirmem tu storian mo history blong Chief Taripoamaata we oli presentem long Court wetem family tri. Witness ia emi talem se emi kamaot long descendant blong Toufabelle, we brata blong em, emi Chief Taripoamata Kalosike. Court emi satisfy se sapos witness ia emi kamaot long Toufabelle, then Toufabelle emi stret descendants blong Leintamate we emi stret pikinini blong Leisavmanu. Witness ia emi tesfity tu mo talem se Chief Masongomapula emi wan smol chief nomo long siviri village.

Witness italem se chiefly title ipass ikam daon kasem late chief Kalosike Taripoamta emi stret follem custom blong mifala blong North Efate. Witness italem se chief Taripoaliu emi wan bigfala chief blong Efate mo offshore Island bifo.

Court iquotem part blong toktok blong Chief Arthur Maosongomapula "*long 1927 chief Taripoaliu Suasavi blong Nguna ikam mekem chief blong siviri, oli ordainem mi, mi karem name blong great-great-grant father blong mi, Chief Masongomapula, mi stap tedei mi karem nem ia. Village blong siviri mifala ikat plate malala, ikat chief blong em, oli bin leftemap mifala wan taem long taem ia. Nao ia olgeta everiwan oli ded finis wetem high chief blong mifala Taripoamata*".


