

## JUDGMENT

Kot emi welkamem everi parties we oli present bifo long court long hearing blong paramon jifly taetol kes blong Nejeng long Lareveth village, Malekula Island.

Kes blong Nejeng ia emi registered bifo long Malekula aelan kot follem *Island Courts ACT CAP 167 section 10. Application of customary law: Subject to the provisions of this Act an island court shall administer the customary law prevailing within the territorial jurisdiction of the court so far as the same is not in conflict with any written law and is not contrary to justice, morality and good order mo tu;*

Bifo kot I harem jifly taetol kes ia claimant emi raisem question se I gat wan Äpplication for struck off"we Defendan # 1 emi filem I kam long kot. Be taem kot I askem defendan 1 emi agree blong Island court I proceed blong harem case blong jifly taetol mo leko Application blong struck off mekem hearing I proceed.

### BACKGROUND BLONG CASE



Defendant 1 Kalondak MELE emi respond long kes ia mo filem response blong em long Monday 05 August 2019 long 2:58pm long afternum.

Defendant 2 Roy HAROLD emi respond long kes ia mo filem response blong em long Friday 09 August 2019 long 9:13am,

Defendant 3 Sethy AIMAN emi respong long kes ia mo filem response blong em long 14 August 2019 long 2:37pm long aftenun.

Papa blong Benmal emi sendem maot Benmal wetem woman blong em mo tufala wokman blong em blong oli I ko markem graon blong olgeta. Sapos oli markem graon finis kasem mark blong olgeta bae oli mekem wan sign blong showem long em.

Benmal emi fes man blong settle long hed blong wota long Momvar mo follem I kam antap long hill long Momvar. Em wetem woman blong em tufala I stap kaekae fruit blong nemel nomo. Tufala kam settle antap long hila ia. Afta samtaem tufala I finemaot se I no bin gat man long ples ia. Tufala I ko tekeem tu nlang mo rubbem tugeta blong mekem wan fire long em. Fire ia emi wan special fire blong mekem sign blong talem maot long papa blong em long solwota mo tufala boe blong em se emi oraet nao blong kam mitim em.



Olfala papa blong jif Benmal I kam wetem pig mo tufala boi blong jif, pupu blong papa blong Nomasing we emi papa blong Smethen mo pupu blong papa blong Nikodemis we em I papa blong Willie tufala tu I kam wetem pig blong registerem lan boundary mo sem taem oli stanemap fes nasara blong Benmal mo nemem se em I “Nejeng” we emi minim ‘sit daon antap’

Taem Benmal I kasem white rooster faol we emi identity blong tribe we I follem em I karem feta blong em putum long hed mod anis wetem, ale papa blong jif Benmal I putum taetol blong nem I we emi “Benumal”, semataem jif Benumal I mekem tufala boe blong em tu I putumap ston blong tufala mo tekemap taetol blong tufala we emi smol fire blong jif Benumal long Nejeng.

Sam taem I pass wan olfala laen blong Mele I kam tru long pupu blong papa blong Nokodemus. Mo pupu blong papa blong Nomasing, tufala I tekem I ko long jif Benumal mo jif benumal I askem long tufala se “whu ia nara man we I kam wetem yutufala?” na tufala I talemaot storian blogn olfala laen blong Mele mo oli serem fire wetem hem. Oli storian long rod blong olfala long laen blong Mele mo finemaot se em I kam maot long wan creek blong wota we emi “Lamre” Hemi luk fire nao em I follem I kam maot long olgeta. Olfala long laen blong Mele I glad tunas blong joenem olgeta.

Jif Benumal I mekem olfala long laen blong Mele I putum stone blong em we I soemaot se emi kam settle wetem jif olsem tabu fire mo nemem em “Telis” we I minim se “em I jes kam”. Long laen blong Mele em I gat wan stone ia nomo we I stap klosap long bigfala nasara blong mi” Nejeng”

Long Tenmiel yet oli gat ol pikinnini blong olgeta mekem oli plante. Afta Samtaem I pas oli stanemap namba 2 nasara blong jif Benumal we em I killem pig mo stanemap stone blong em mo putum nem blong em “Harven” we I minim se “oli plante”.

Em I nemem nasara ia “Tembimm” we I minim se I smol I stap, long Tembimm nao boe blong jif Benumal I bon oli putum nem blong em “Dasdamp” we I minim se “ples I empty”. Oli stap long ples ia kasem olfala Benumal mo wife blong em I ded.

Afta sam taemi pas wetem relationsip we man Negeng I gat wetem Vara mo olman tape, evriwan I wok tugeta blong stanemap ston mo Desdamp I kilim pig blong kohed blogn leftemap taetol blong em olsem jif blong Nejeng. “Amelnevet” em I nem blong nasara we I min se “nakamal blong ston” long Varea ia yet Urenmal wan (1) boe blong Dasdamp I bon.

Ol apu long Vare mo tufala smol fire blong Nejeng we emi apu blong Willie mo apu blong Smethen, oli kam tugeta mo stanemap stone mo mekem "Urenmal" I killem pig blong karem taetol blong jif blong Nejeng mo nem blong Urenmal 1 we I minim se "putumap jif" Nem blong nasaraia emi "Amelsnef" we I minim se nakamal long wan "smol level ples".

Lingi I smol mo no gat man blong lukaotem emmekem Urenmal, papa blong Lingi I karem em I ko long ol uncle blong emlong Hartelemb blong oli lukaotem em. Emi life long han blong ol uncle blong em taem Ia oli live long Lendo mo Ameliakus we emi bigwan, emi kam bak. Be emi kasem big leg mo emi blaen mekem emi no killem pig blong karem taetol, be ol pipol we oli liv long Larveth long taem ia mo Tapet tribe oli save se Lingi em blood line blong jif blong Nejeng.



Emi statem tu se foundation blong Nejeng long histri blong em I gat 1 pig we I gat 3 pikinnini we fes pikinnini blong pig emi bigfala jif mo scond pig emi smol fire mo las bon blong pig emi tambu fire we emia nao emi governing system we I blong Nejeng we I stap bifo finis kasem tedei.

Emi statem tu se histri blong Lingi Jack Huren someples long yia 1920's ol man blong Nejeng oli ko long wan kastom ceremony antap long Lendo mo Lambumbu during long ceremony iaoli faenem se boy ia Lingi I bin ko long toilet insaed long nakamal moo 1 man long nasara ia oli decide blong killem em, be long taem ia ol man Nejengoli decide blong tekem em I kam long Larevat mo tekem gud care long em kasem taem emi bik wan mo ol man Nejeng oli mekem emi circumcise.

Afta long circumcise apu Willie Wengin I pem nambas I ko long uncle blong em Kara. Apu Willie Nejeng I pem wan woman blong em we nem blong Susan oli pem em long house blong Apu Peter we emi papa blong elder Kapi.

Harol mo Susan tufala I stap sam years afta tufala gat fes bon boe blo tufala we nem blong em Wasande Harol. Wasande Harol emi stap wetem apu Willie Nejeng kasem taem emi ded. Apu Willie emi ded long dremdrem afta mifala I berem em long Bakaret.

#### ***DEFENDAN # 3 SETHY AIMAN***



Olgeta ancestors blong family Aimani oli kam maot long family bladlaen blong hae jif we emi paramount tumas insaed long Mosok eria. Afta we Maternal hae jif blong Utar, ol traebz blong hem oli arrive mo laef long Utar, oli sitemap nasara blong



olgeta. Long taem bifo 1800's bladlaen blong Maternal hae jif blong Utar oli bin stap mo risivim samfala traefs mo laef long Utar.



4. Maternal emi save I gud ol traefs blong Utar we oli laef I stap long Mosok Boundri. Mo tu I gud blong clearem long honorable kot ia se paramon jif blong Mosok kastom land boundri oli laef bladlaen blong em oli still laef tedei we emi family Aiman Swelle Maternal. 6. Long kastom governance setap hae jif blong Mosok long taem bifo kasem tedei emi save hu emi tru mor aet jif long ol smol baondri ia mo tedei long honorable kot ia , mi olsem bladlaen blong paramon hae jif blong Mosok kastom lan baondri I tekem taem ia blong mekem decleresen blong olgeta rightful jif blong ol following baondris ia follem kastom ruls blong bifo:
  - A) Long denmel baondri emi Philip we kastom nem blong em emi Metermal we emi bladlaen blong family Aiman. So, family Aiman jif blong Utar emi laef yet blong tekem bak graon ia mo I kam jif blong Denmel tedei.
