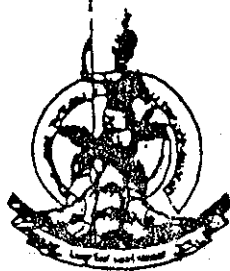

DECENTRALIZATION (DATE OF ELECTION OF SANTO/MALO,
PENTECOST AND EFATE RURAL LOCAL GOVERNMENT COUNCILS)

ORDER No 35 OF 1987

To declare the date for the start of elections for councillors to the SANTO/MALO, PENTECOST and EFATE RURAL Local Government Councils.

WHEREAS:

- (a) The four year term of the SANTO/MALO, PENTECOST and EFATE RURAL Local Government Councils expires on or about 18th August, 1987 ; and
- (b) Elections need be held for the named councils in accordance with the Decentralization Act No 11 of 1980 ;

NOW THEREFORE, IN EXERCISE of the powers contained in section 8(2)(a) of the Decentralization Act No 11 of 1980 as amended, the **ELECTORAL COMMISSION** HEREBY MAKES the following order:

DATE OF ELECTION

- (1) The election for councillors to the Local Government Councils of SANTO/MALO, PENTECOST and EFATE RURAL shall all commence on 19th August, 1987.


RETURN OF CANDIDATURE

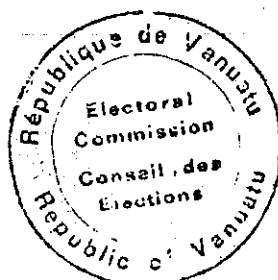
- (2) Eligible persons may submit their declaration of candidature for the above councils elections as from the date of signature of this order until not later than 4.30 p.m. on the 17th July, 1987 to the Principal Electoral Officer in Vila or to the respective Local Government Council Secretary.


COMMENCEMENT




ORDER REVOKING BANKING LICENCE
