**DECENTRALIZATION (DATE OF ELECTION OF SANTO/MALO,  
PENTECOST AND EFATE RURAL LOCAL GOVERNMENT  
COUNCILS) (AMENDMENT) ORDER No. 40 OF 1987**

To change the date of return of candidature for **PENTECOST** Local Government Council Election.

**WHEREAS** due to unforeseen delays, a change in the date of return of candidature for **PENTECOST** Local Government election has become necessary;

**NOW THEREFORE, IN EXERCISE** of the powers conferred by section 8(2)(a) of the Decentralization Act No. 11 of 1980, as amended, the **ELECTORAL COMMISSION HEREBY MAKES** the following Order:

**AMENDMENT**

1. Section 2 of the Decentralization (Date of Election of Santo/Malo, Pentecost and Efate Rural Local Government Councils) Order No. 35 of 1987 is repealed and the following sections are substituted -

**"RETURN OF CANDIDATURE IN RESPECT OF SANTO/MALO AND EFATE RURAL LOCAL GOVERNMENT COUNCILS**

- (2) Eligible persons in respect of Santo/Malo and Efate Rural Local Government Councils may submit their declaration of candidature for those Councils elections as from the 2nd of July, 1987, until not later than 4.30 p.m. on the 17th July, 1987, to the Principal Electoral Officer in Vila or to the respective Local Government Council Secretary.

**RETURN OF CANDIDATURE IN RESPECT OF PENTECOST LOCAL GOVERNMENT COUNCIL**

- (2A) Eligible persons in respect of the Pentecost Local Government Council may submit their declaration of candidature for that Council's election, not later than 4.30 p.m. on Friday 24th July, 1987, to the Principal Electoral Officer in Vila or to the Local Government Council Secretary."

**REPEAL**

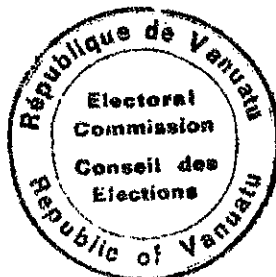
2. The Decentralization (Date of Election of Santo/Malo, Pentecost and Efate Rural Local Government Councils) Order No. 39 of 1987 is repealed.

**COMMENCEMENT**

3. This Order shall come into force on the date of its signature.

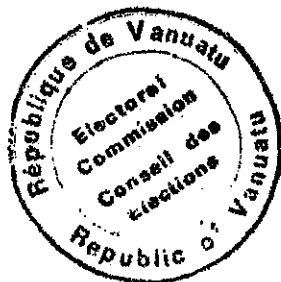

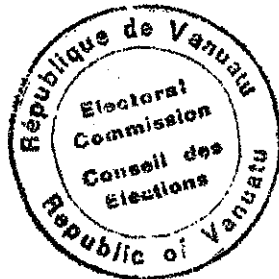

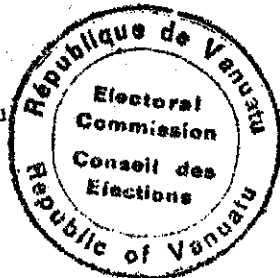
