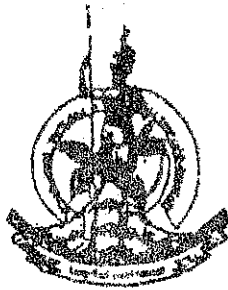

THE MINIMUM WAGE AND MINIMUM WAGES BOARD  
(AMENDMENT) ACT NO. 4 OF 1987

An Act to amend the Minimum Wage and Minimum Wages Board Act, No.42 of 1984.

BE IT ENACTED by the President and Parliament as follows:-

**AMENDMENT OF SECTION 5 OF ACT NO.42 OF 1984**

1. Section 5 of the Minimum Wage and Minimum Wages Board Act, No.42 of 1984 (principal Act) is amended by the insertion immediately after subsection (3) of that section, the following new subsection:-

"(4). The Minister may, if he thinks that any member of the Board has failed to contribute constructively towards the better performance of the functions of the Board, terminate the appointment of such member to the Board."

**AMENDMENT OF SECTION 6 OF THE PRINCIPAL ACT**

2. Section 6 of the principal Act is amended by the repeal of subsection (1) of that section and the substitution therefor, of the following subsection:-

"(1). The Minister shall appoint as Chairman and Vice Chairman respectively, two members of the Board who in the opinion of the Minister have the capacity to perform effectively the functions of their office."

**COMMENCEMENT**

3. This Act shall come into force on the day of its publication in the Gazette.

**MODIFICATION DE L'ARTICLE 5 DE LA LOI NO.42 DE 1984**

1. L'article 5 de la loi no.42 de 1984 (loi cadre) est modifié par l'insertion du nouveau paragraphe qui suit, immédiatement après le paragraphe 3 :

"4). Le ministre peut, s'il estime qu'un membre du Conseil a manqué de contribuer de manière constructive à une meilleure exécution des missions du Conseil, mettre un terme au mandat dudit membre du Conseil".

**MODIFICATION DE L'ARTICLE 6 DE LA LOI CADRE**

2. L'article 6 de la loi cadre est modifié par l'abrogation du paragraphe 1) dudit article et l'insertion du paragraphe qui suit :

"1). Le ministre peut nommer respectivement aux postes de président et vice-président, deux membres du Conseil qui, selon l'avis du ministre, ont la capacité de remplir efficacement leurs fonctions.

IN EXERCISE of power conferred by section 26 of the Decentralization Act. No.11 of 1980, that TAFEA Local Government Council hereby makes the following regional laws:-

AMENDMENT OF HEAD TAX REGIONAL LAW No. 1 OF 1982.

1. The TAFEA Local Government Council the Head Tax Regional Law No. 1 of 1982 is amended by repealing paragraph 3 and substituting the following paragraph -

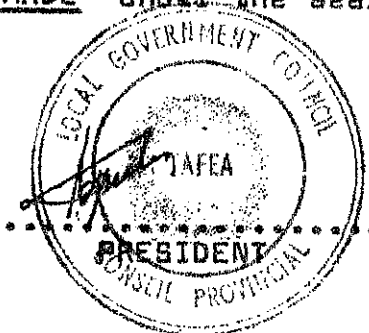
"3. The Head Tax shall be assessed as follows:-

- (a) Males 700 vatu;
- (b) Females 300 vatu."


