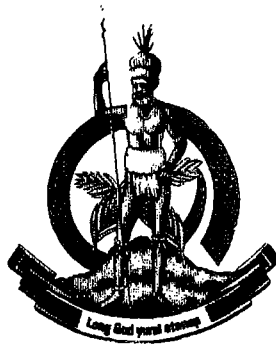

Official Salaries (Amendment) Order No. 43 of 2008

To amend the Official Salaries Order No. 25 of 2008.

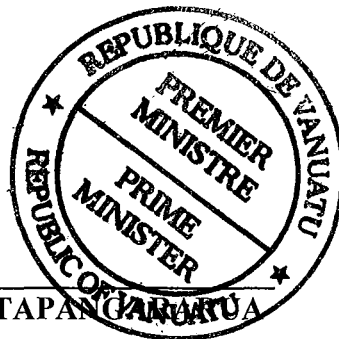
1 Amendment

3 Item 2 -After CLASS W (3)

Insert

“(4) For each year of service by a person in a government Ministry or the office of the Speaker at Parliament for a period of less than 3 years, a goodwill payment which is to be paid on a pro rata basis following the rate set out in CLASS W(3).”




APPOINTMENT OF JUDGE OF THE SUPREME COURT


JUSTICE NEVIN DAWSON

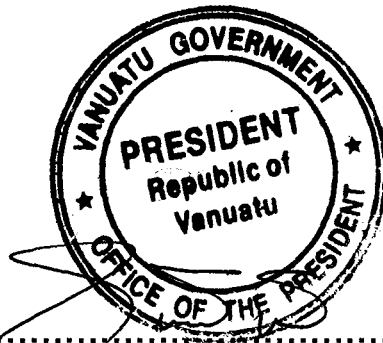

JUDICIAL OATH

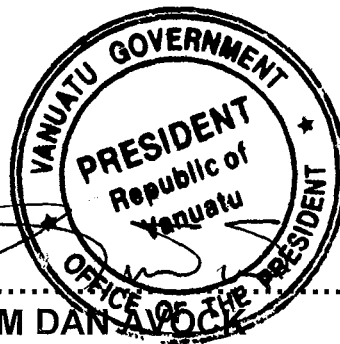
