**Detainee Name:** Elodie Bela Temakon

**Decision:** His application is approved. She will remain on parole on conditions to her end sentence date in March 2022. We are satisfied from her report she is adequately rehabilitated to be released on parole. We note her work plan. We urge Probation to assist her to ensure her plan is viable after her release.

**Release Condition:**

- Undertake the Niufala Rod Program from the Probation Services
- To reside at Freshwota 4 with her three children and sister and not to change location prior to the Probation Officer.
- To be supervised by Chief Roland Wawa till sentence end date
- Undertake Rehab programs as well as church programs
- To continue with her sewing business
- Avoid re-offending

**Release Date:** Within 1 week from the date of decision

**Detainee Name:** Viliami Baleratu Vulilangilagi

**Decision:** His application is approved based on his positive report. We note his work plan. He needs to be introduced to the Agriculture Dept by Probation and he needs constant monitoring thereafter to ensure the project works for him.

**Release Condition:**

- To reside only at Fresh Wota (six) G area and no other place else.
- To be under the care and responsibility of Chief John Yawei
- To undertake spiritual counselling as directed by a Probation officer
- To undertake Niufala Rod Program as directed by a Probation officer
- To undertake any rehabilitation programs as directed by a probation officer
- Not to re-offend

**Release Date:** Within 1 week from the date of decision

**Certificate of Decision:** Certify as true record of decision

**Detainee Name:** Melten John

**Decision:** His application is approved. We are satisfied from his reports that he has attended programs and that he has adequately been rehabilitated to the point of being no risk to the community. He has a good work plan. He needs to be assisted by the Probation services by reference to the relevant government department for further advise and assistance. He would need continued monitoring thereafter to ensure his project works to his benefit.

**Release Condition:**

- To be supervised by Chief Albert Kolau until send of Parole Sentence
- To undertake any rehabilitation program as directed by the probation officer
- Not to change residential location without prior approval to the probation officer
- To undertake Niufala Rod Program as directed by the probation officer
- To perform a custom reconciliation to his chief and the community of painting a bad reputation to his community
- To keep his distance away from the victim nor to make no contact in any form either by phone ...ect
- Not to re-offend

**Release Date:** Within 1 week from the date of decision

**Detainee Name:** Paul Sablong

**Decision:** We are satisfied he is adequately rehabilitated. He has good chiefly support with a good work plan. We recommend probation service introduces him with his project to the appropriate government department for further assistance and continued monitoring to ensure the project works to his benefit.

**Release Condition:**

- That he reside at Road Erakor only
- That he undertake any programs as directed by the probation officer
- To undertake niufala rod program as directed by probation officer
- To undertake spiritual counselling as directed by probation services and chief
- To undertake victim counselling with his supervising probation officer
- His is not to re-offend or commit any other offence.

**Release Date:** Within 1 week from the date of decision

**Detainee Name:** Dick Sam Tari

**Decision:** His application for parole is approved. He will remain on parole on conditions until his sentence end date being 08/09/2021. We recommend the probation service assist him with his work plan by introducing it to the appropriate government department and to monitor the project thereafter.

**Release Condition:**

- He must undertake the Niufala Rod program by the probation services and other rehabilitation programs.
- To undertake spiritual counselling with Pastor John Leeman
- To Reside back with his family at Eton Village and not to change residual location without prior from the Probation Officer
- To be supervised by Chief Hendry Vakamoli till sentence end date.
- Not to re-offend
